**Second Week:** From August 24 to August 29, 2026 (as per the attached program). Upon prior payment for the selected courses, you can participate in 5 days of contemporary dance workshops, which also include the creation of performances.

Furthermore, on August 28 and 29, 2026, participants in the workshops will have the opportunity to take part in performances, starting at 9:00 PM in Taranto.

## TERMS AND CONDITIONS

Event named CORA DANCE FESTIVAL organised by ASD/APS Spazio 8

### 1. General

Course registrations must be made via email.

Registrations are legally binding and non-transferable.

Candidates accepted into the selection process will be notified and will receive confirmation via email. Candidates will not have a confirmed spot in the course until the course fee has been fully paid.

Registrations are processed in the order of receipt of the course fee. If the maximum number of participants is reached, or if the required minimum number of participants is not met, subsequent applicants will not be eligible to participate.

Partial participation is not allowed.

Registration implies the applicant's acceptance of the general terms and conditions and the internal regulations of the course venues.

If the venue's rules differ from these general terms and conditions, the venue's rules will take precedence.

The parts of the general terms and conditions not affected by the venue's rules will remain unchanged.

It is not allowed to enter the dance venues with outdoor shoes. Additionally, eating is not allowed inside the dance venues.

Drinks may only be consumed by workshop participants, and glass bottles are not allowed in the studios. The soles of shoes worn in the dance studio must be non-abrasive.

The costs for repairing damage to the dance floors (particularly marks left by shoe soles) are the responsibility of the person who caused the damage.

### 1. Course Fee and Cancellation by the Participant

The course fee must be paid to the bank account indicated in the email.

The organisers have the right to cancel and/or interrupt a course in the event of insufficient participants or due to force major.

In such cases, course fees will be refunded in full or on a proportional basis if the course is interrupted after it has started.

If a course instructor is unavailable for the entire course or part of it, the organiser has the right to provide a substitute instructor.

However, participants also have the right to cancel their registration for the substitute course, but the course fee or the respective fraction of it will not be refunded.

In this case, participants waive any claims against the organiser for the reimbursement of any additional expenses, such as travel and accommodation costs.

### **3. Cancellation by the Participant**

Cancellation must be communicated in writing to be valid.

Registration is binding, and the course fee is due if the participant is invited by the organisers and commits to participating.

The payment of the full course fee constitutes the participant's binding registration for the workshop.

Once the registration payment has been made, no refunds will be issued under any circumstances. If the reason for cancellation by a participant is an injury or illness, upon submission of a medical certificate, 20% of the total registration fee paid will be refunded.

If the festival has already started, the fee will be refunded proportionally.

An administrative fee of €10 will apply. For all transfers, all participating banks and institutions charge transfer fees. These transfer fees must be fully covered by the participant. If the fee is incomplete due to the deduction of transfer fees, the participant must pay the difference.

All refunds granted and processed by ASD/APS Spazio 8 will be refunded minus the transaction fees associated with the return.

The participant agrees that workshops present a flexible working environment and that the way workshops are advertised may differ partially from their actual execution. The participant furthermore agrees that disliking a workshop is not a reason to get refunded. In order to uphold the integrity of the workshops, Spazio 8 ASD/APS does not, in any case, support changing workshops due to any personal dislike of the workshop.

### **4. Liability**

Participants assume the risks associated with the event.

If there are known medical conditions that would pose a risk to a participant, participation in the related activities is expressly prohibited, and the organiser assumes no responsibility.

The organiser reserves the right to permanently exclude participants from the festival workshops who do not adhere to the venue rules and/or who deliberately disrupt the lessons in any way; course fees will not be refunded. The organiser assumes no responsibility for damages, injuries, or losses. Insurance is not included.

The organiser is not liable for any inconveniences that may arise.

There is no insurance coverage for injuries or health-related issues that cover participants during the course or during any excursions related to the course.

The organisers assume no responsibility for the loss of any personal belongings.

The explanations and information provided by the instructors are solely for the direct purpose of conducting the course or event and cannot be interpreted as supporting any liability claims.

In case of disturbance or incident, course participants are required to take all reasonable measures to help eliminate such damage or disturbance. The organiser's liability is limited to gross negligence and intent.

### **5. Pandemics**

In the event of a pandemic, workshops, performances, and any presentation involving more than one person in a room must be held with the measures provided by the organisers.

Both organisers and participants are required to follow the applicable rules at all times, regardless of whether these restrictions are known before or during the workshops, performances, conferences, etc.

## **6. Travel and Quarantine**

Participants are responsible for following quarantine rules for safety reasons or for crossing borders, if necessary.

The measures and rules implemented by governments, states, districts, travel companies, institutions, and organisers may change due to the pandemic, both before and during the festival, and before and during the Participant's travel.

## **7. Program Modifications or Workshop Cancellation**

The organiser is responsible for making every effort to maintain the original schedule. However, the organiser does not guarantee that the program will take place as planned due to force major.

The organiser cannot compensate for any financial losses resulting from travel, quarantine, or any non-refundable funds.

Workshops that are held partially or not at all due to force major will not be refunded.

## **8. Data Protection**

Emails are currently transmitted without using any sophisticated encryption system. Therefore, there is a risk that the information sent could be viewed by third parties. We advise participants not to send passwords, credit card numbers, or any other sensitive information that they wish to protect. All data will be processed and handled in accordance with applicable data protection laws. Under Italian data protection law, personal data will be stored in a machine-readable format. The data will not be shared with third parties. The disclosure of contact information of our participants, instructors, assistants, etc., is prohibited by data protection laws.

## **9. Photo and Video Recordings**

During the festival days, the organiser will be recording photos and videos for PR purposes. The material will be used without disclosing any personal data. By registering, participants consent to this and cannot claim access to the filmed and photographed material. Photography and video recording are not allowed during the lessons. Exceptions are subject to a written agreement with the organiser. Exceptions are granted for the media, TV, etc. Any use of images, texts, or other content without written permission is strictly prohibited. Failure to comply will result in criminal and civil actions.

Spazio 8 ASD/APS reserves the right to make an edited video and photo material of performances (except for the creations) available to all people involved (including choreographers, dancers, and assistants), and downloadable images, under the following conditions:

any video and/or photo material that is made public by them in any way must be credited with the following wording: the respective title of the piece, the choreographer, the year of the festival/premiere, and the videographer's/photographer's name has to be filled in.

“...”(the title of the piece which has been created) has been created by “...” (name of the choreographer) and presented at the CORA Dance Festival in Taranto “...” (year of the festival).  
video:“...” / photo “...” (videographer's/photographer's name)

all material must be used as provided by Spazio 8 ASD/APS. it is forbidden to alter and/or change the content in any way, as well as sharing the files with unauthorized third parties (including people and institutions) without written permission by Spazio 8 ASD/APS.

**10. Validity and Jurisdiction**

For any disputes, the competent court is the Court of Taranto.

**10. Partial invalidity**

In the event that any one or more of the provisions of these general terms and conditions are or become legally invalid as a whole or in part, the validity of the remaining provisions shall not be affected thereby. Any such invalid provision shall be retroactively replaced with a provision whose contents shall be as identical as possible, and which reflects the purpose of these general terms and conditions to the maximum extent possible. Oral side agreements are not valid unless accepted in writing by the management of Spazio 8 ASD/APS. The validity of the general terms and conditions in their entirety remains unaffected. The original version of these general terms and conditions were prepared in Italian. a translation, if any, shall solely serve as a convenience translation for the parties. in the event of any conflict between the Italian and english versions hereof, the Italian version shall prevail.
